STREET HERO stalked the pace inside, inched forward on the second turn, was in a bit tight off heels nearing the stretch, came out into the lane, bid three deep a sixteenth out to gain the lead under some urging in late stretch and gamely prevailed. MIDSHIPMAN pulled his way along three deep then chased outside, went three wide again on the second turn and four wide into the stretch and just got the place. BELIEVE IN HOPE a bit slow to begin, chased a bit off the rail or inside, came out slightly on the second turn, angled back in entering the stretch and finished willingly along the fence. DEL CONTE a bit washy at the gate, had speed outside a rival then inched away and angled in, set the pace inside, fought back a bit off the rail in the stretch and between foes through the final sixteenth and was narrowly outfinished for a minor award. SILENT VALOR was in a good position stalking the pace three deep to the stretch, loomed a threat in midstretch but could not quite summon the necessary late response. AZUL LEON settled inside then a bit off the rail, came out three deep into the stretch and lacked the needed rally. TIGER BLITZ broke in and bobbed, drifted four wide into the first turn, chased outside a rival, came out leaving the second turn and four wide into the stretch and was not a threat. REGAL RANSOM pulled his way along inside then a bit off the rail, stalked between horses, was in a bit tight while weakening into the stretch and fell back. LITURGICAL close up stalking the pace between horses, dropped back inside on the second turn and had little left for the stretch.
