LAWYER RON well rated early behind the pace, moved strongly to the fore on the outside under his own courage through the second turn, daylighted the field when straightened for home, increased advantage under only token encouragement to win ridden out. BROTHER BOBBY settled off the pace, asked for some run late in the second turn, outside through the stretch, held the place. BOBOMAN far back, began to run in the second turn, rallied on the outside, getting to the runner up. JONESBORO broke on top, clear early, set the pace along the inside, put in a bit tight when MCCAIN'S MOJAVE came in a bit turning for home, faded. MCCANN'S MOJAVE pressed the leader outside, came in a bit turning for home, weakened. SMOKEYJONESSUTTON steadied nearing the wire the first turn when PAPAI CHULLO came in, raced well back, did not fire. PAPI CHULLO came in early to bother SMOKEYJONESSUTTON, gave way after six furlongs, well beaten.
