WILL TAKE CHARGE broke back, lacked speed, moved out, four wide into and through the final turn, challenged on the outside turning for home, brushed with GOLDEN LAD, drifted in nearing the furlong marker to help tighten up that foe, continued to come in with less than a furlong remaining to slightly bother REVOLUTIONARY under a right handed stick each time, continued under firm handling the the wire. FOLLOWING A STEWARDS' INQUIRY REGARDING THE STRETCH RUN AND RIDERS CLAIMS OF FOUL BY THE JOCKEYS OF BOTH REVOLUTIONARY AND GOLDEN LAD AGAINST THE WINNER, THE RESULT WAS ALLOWED TO STAND. REVOLUTIONARY back off the pace and the rail, in some traffic into the lane, came out to help tighten up GOLDEN LAD nearing the furlong marker resulting in that one to steady, bothered himself soon after when the winner continued to drift in, finished up with good courage to be clearly second best. CARVE broke out, recovered to race forwardly and along the inside, slipped through along the rail to challenge into the lane, could not match strides with the top two the final furlong. PRAYER FOR RELIEF settled off the pace outside, stalked three wide in the run up the backstretch, fell back, four wide into the lane, improved a bit the final furlong while not a serious threat. GOLDEN LAD pressured the early leader on the outside, between foes into the lane, was going evenly when forced to steady in tight quarters a furlong out, continued one paced to the wire after recovering. RIGHT TO VOTE broke on top, got clear before a quarter, set the pace toward but not on the inside, allowed CARVE the rail when beginning to tire in upper stretch, continued to weaken.
