EFFINEX forwardly placed from the outset while three wide into the first turn, continued to apply pressure early backstretch, called on for some run with just over a half mile remaining, engaged the leader soon after, dueled through the second turn and into the stretch, continued spirited duel to the wire, proved best under steady handling. MELATONIN broke well, showed the way into the first turn in hand, slowed the pace down the second quarter, picked it up when confronted by the winner into the far turn, dueled to the wire and gave ground grudgingly to the winner, clearly second. POINT PIPER broke to the inside, was straightened and settled behind the pace while saving ground, worked way out to the three path into the lane, set down briskly for the drive, staged a mild rally to gain the show, no real threat to the top two. BLOFELD in the second flight while racing in the two path, asked along second turn, little in the way of response, caught late for the show. UPSTART last away, raced back and outside, five wide through the final turn, failed to muster a rally when called on. DOMAIN'S RAP lacked early foot, floated out five wide into the first turn, back, four wide and in some traffic late in the second turn, remained back through the stretch. CARVE forwardly placed into the first turn, angled out to be four wide in the first turn, stalked the pace outside, gave way in the drive. FINANCIAL MODELING forwardly placed early while between foes, faded then stopped into the lane, distanced, walked off.
