CRUMB fell back after the start, moved up into a striking position late backstretch and into the turn, three wide through the bend, lost some ground to the leaders into the stretch, late surge outside to be in time. **LAVALETTE GOLD** pressured the leader from the start outside, dueled with that foe into the lane, put a head in front inside the furlong marker, could not contain the winner. **DREAMLICIOUS** within striking distance toward the inside, fell back a bit in the turn while continuing toward the rail, shifted out for the drive, found some late energy to be in time for the show and was slowly getting to the runner up. **R FREE ROLL** set the pace while in hand and saving ground, shaken up when confronted upper stretch, vied until late, faltered. **TOASTING** broke slowly, trailed well back early as a result, advanced through the turn, closest while four wide turning for home, flattened out in the drive while well out in the strip. **CANDY CODED KISSES** off the pace and the inside, raced four wide through the turn, had nothing left for the stretch run.
