1 1/4 MILES. (1.472) STAKES. Purse \$300,000 OHIO DERBY(GRADE II) FOR THREE-YEAR-OLDS. By subscription of \$300 by Wednesday May 23,2007, Or all horses which have started in Graded Stakes at any Magna Tracks in 2007 shall receive a Free Nomination. Supplementary nominations accepted to the Ohio Derby of \$5,000 due by Tue sday May 29,2007, \$1,500 to enter and \$1,500 additional to start with \$300,000 Guaranteed, of which 60% to the winner; 20% to second; 10% to third; 5% to fourth; 3% to fifth; and 2% to sixth. Weight: 124 lbs. Non-Winners of \$100,000 twice at a mile or over in 2007 allowed 3 lbs; of \$100,000 at a mile or over in 2007; 5 lbs; of \$100,000 at any distance 7 lbs; of \$50,000 at any distance 9 lbs. (MCOS not considered in weight allowances) The Ohio Derby will be limited to fourteen (14) Starters, in the event more than fourteen (14) entries pass the entry box by 10:30 A.M.Eastern Standard Time, Thursday May 31, 2007, preference will be given to those horses having accumulated the highest lifetime earnings at the time of closing entries. Lifetime earnings will be determined according to statistics provided by Equibase. A Trophy to the winning Owner, Trainer & Jockey. (Clear 86)

DELIGHTFUL KISS was allowed to settle, rallied at the three eight's pole while three wide with a quick move, gained command at the top of the stretch and widened through the lane under intermient urging. MOYER'S POND stalked the pace, rallied at the top of the stretch while saving ground, could not gain on the winner but held place late. REPORTING FOR DUTY unhurried early, rallied through the stretch on the inside and finished well. COWTOWN CAT stalked the pace while three wide, lacked a late response in the stretch and went evenly. FORTY GRAMS set the pace and dueled for the lead, then weakened slightly in the stretch. STARBASE pressed the pace, drew even at the three eight's pole, then lacked a late response through the lane. OFFICER ROCKET (GB) was well placed early, faltered on the second turn. DANNY SEZ was allowed to settle but failed to menace.
