(GRADE III) FOR FILLIES, THREE YEARS OLD.** By subscription of \$100 each by Saturday, December 20, 2008, which shall accompany the nomination, \$1,000 to pass the entry box and \$1,000 additional to start, with \$100,000 Guaranteed. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$60,000; \$20,000 to second, \$10,000 to third, \$5,000 to fourth, \$3,000 to fifth and \$2,000 to sixth. FROLIC'S DREAM hit the gate at the start, chased the pace along the rail, angled outside the leaders for the stretch run and rallied to just miss. CASANOVA MOVE tracked the leaders three wide around the turn and tired. HONCHIS'N PONCHIS saved ground and faltered. SWEET REPENT was not a factor. REDREAMIT off slowly, steadied along in behind rivals on the backstretch and faded.
