LOTS O' LEX stalked the pace two wide, seized command in upper stretch, drew clear and held clear under a drive. NO FAULT OF MINE lacked early speed, advanced inside around the far turn, tipped two wide nearing the lane, waited for room in upper stretch and rallied once clear in midstretch. FLEET BERTIE led early, settled back into a stalking position nearing the turn, was blocked in upper stretch and finished willingly once clear. COMPLETE ST. lacked speed, raced three wide and rallied belatedly. ENTRECHAT chased the pace two wide and lacked a rally. AMERICA MON AMIE advanced outside to take the lead near the five-eighths pole, cleared and set the pace along the rail around the turn and weakened in the lane. INSIDE OUT was outrun inside. ANNULMENT steadied early, raced two wide and never threatened. CABANA chased three wide and was through early.
