MAYLA set the pace early, shifted into the three path in the turn, came in nearing the eighth pole and inched clear late under a steady drive. GRACE'S TREASURE stalked the pace early, shifted into the four path in the turn, made a bid three wide in the stretch but flattened out late in the drive. ATHENA chased the pace early, fanned into the five path in the turn, made a late bid three wide in the stretch but weakened in the final stages. TRICKY ZIPPY was unhurried early, swung into the six path in the turn and moved up in the stretch run. PROFOUND MOMENT was done early and avoided fallen foe in the stretch. IVY BELL trailed the field early, made an inside bid entering the lane, was put in tight, clipped heels and lost the rider nearing the eighth pole. AFTER A STEWARDS INQUIRY, MAYLA WAS DISQUALIFIED AND PLACED LAST FOR INTERFERENCE IN THE STRETCH RUN.
