1 1/2 MILES. (2.071) STAKES. Purse \$1,000,000 *PACIFIC CLASSIC S. PRESENTED BY TVG (GRADE J) FOR THREE-YEAR-OLDS AND UPWARD.* By subscription of \$300 each to accompany the nomination. The Pacific Classic has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The winner of the Pacific Classic will be entitled to automatic entry into the 2010 running of the Breeders' Cup Classic, subject to the payment of all pre-entry, entry and supplementary (if applicable) fees. To be eligible for the 2010 Breeders' Cup Championships to be held at Churchill Downs on November 5-6, 2010, all horses must be pre-entered by noon (local time at the designated pre-entry locations) by October 25. All horses shall pay \$2,500 to enter and \$12,500 additional to start, with \$1,000,000 Guaranteed, of which \$600,000 to the winner, \$200,000 to second, \$120,000 to third, \$60,000 to fourth and \$20,000 to fifth. Three-year-olds, 118 lbs.; older, 124 lbs. Trophies will be presented to the winning owner, trainer and jockey. Nominations closed Thursday, August 19, 2010 with 16. (Clear 74)

RICHARD'S KID settled outside, went three deep into and on the second turn, came out five wide into the stretch and rallied under left handed urging while drifting in to gain the lead in late stretch and gamely prevailed. CROWDED HOUSE (GB) chased outside a rival then between horses into the second turn, continued a bit off the rail on that turn, went three deep into the stretch, took a short advantage between foes past the eighth pole, fought back inside the winner in deep stretch and continued willingly. DAKOTA PHONE unhurried a bit off the rail early, came out on the second turn and four wide into the stretch and finished well. BATTLE OF HASTINGS (GB) stalked the pace inside, came out into the stretch, was a bit crowded between horses off heels a sixteenth out and was outfinished. THE USUAL Q. T. stalked the pace outside, came four wide into the stretch, took a short lead nearing midstretch, fought back past midstretch but weakened some late. TEMPLE CITY close up stalking the pace off the rail, bid alongside the pacesetter on the second turn, put a head in front leaving that turn, battled between horses in midstretch and also weakened late. ISLE OF GIANT'S took the early lead and set a moderate pace under a rating hold a bit off the rail then inside, dueled along the rail leaving the second turn, fought back inside in the stretch and weakened in the final furlong. HOLD ME BACK pulled his way along to stalk the pace outside a rival then off the rail, dropped back on the second turn, came three deep into the stretch and weakened. UNUSUAL SUSPECT angled in early and saved ground chasing the pace, cut the corner into the stretch and did not rally. AWESOME GEM angled in and settled outside a rival chasing the pace, came three deep into the stretch, moved up some in midstretch, staded in tight between foes a sixteenth out and dropped back.
