1¹/₄ MILES. (Turf) (1.442) STAKES. Purse \$150,000 *PALM BEACH S. (GRADE III) FOR THREE YEAR OLDS.* (\$15,000 bonus for FTBOA Registered Florida-Bred by an FTBOA Registered Florida Sire). Free nomination, \$1,500 to pass the entry box and \$750 additional to start, with \$150,000 Guaranteed. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$90,000, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to sixth. Weight: 122 lbs. Non-winners of a graded stakes over a mile on the turf allowed 2 lbs.; of a sweepstakes at a mile or over 4 lbs.; of two races other than maiden or claiming at a mile or over 6 lbs. In the event this stakes is taken off the turf, it may be subject to downgrading upon review of the Graded Stakes Committee. Trophy to the winning owner. Closed Saturday, February 15, 2014 with 48 Nominations and 1 Supplemental Nomination. (If deemed inadvisable to run this race over the turf course, it will be run on the main track at One Mile and One Eighth) (Rail at 84 feet). (Clear 79)

GALA AWARD chased the pace three wide, rallied to gain a slim lead inside the eighth pole, then was all out to hold off MR SPEAKER.

The latter, outrun after being steadied in the early going, swung out for the stretch run and rallied to be up for the place. STORMING INTI set the pace along the rail to inside the eighth pole, then gave way grudgingly. PLEUVEN (FR) rated off the pace, advanced off the rail to loom a threat in midstretch but couldn't gain late. CAN'THELPBELIEVING (IRE) allowed to settle, closed ground late without threatening. MY STORM TROOPER chased the pace off the rail, came in on the far turn, then tired. CABO CAT failed to menace. MORNING CALM reserved off the pace, raced three wide and lacked a rally. SO LONESOME was no factor while racing three wide. PATENT was tracking the pace along the rail, when steadied to avoid running up on MY STORM TROOPER on the far turn and faltered. SMART COVER was outrun after stumbling at the start. TWO JACKS WILD was never close after being steadied in the early going.
