1 MILE. (1:331) STAKES. Purse \$400,000 Pat Day Mile S. presented by LG and E and KU (Grade III) FOR THREE YEAR OLDS. By subscription of \$300 each, which should accompany the nomination or by Supplementary Nomination of \$8,000 at time of entry. \$2,000 to pass the entry box; \$2,000 additional to start, with \$400,000 guaranteed. After payment of 1% toll owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 123 lbs. Non-winners of a grade I or II stakes since October 1, allowed 3 lbs.; a graded sweepstakes in 2019, 5 lbs. The maximum number of starters for the Pat Day Mile will be limited to fourteen (14). If more than fourteen (14) entries pass the entry box preference will be given to graded stakes winners (in order I-II-III), then highest career earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box at the usual time of closing. All supplementary nominations will be required to pay entry and starting fees if they participate. Trophy to winning owner. Closed Saturday, April 13, 2019 with 58 nominations. (Showery 65)

MR. MONEY attended the pace under a snug hold between rivals, split foes and took over nearing the quarter pole, quickly opened clear and widened through the drive. HOG CREEK HUSTLE settled four wide, moved with the winner leaving the turn, split horses and kicked on well but was unable to match strides with the winner. DREAM MAKER broke slow and bumped with MR MONEY BAGS at the start, was unhurried into stride, responded when roused with three furlongs to run, made up ground circling six wide, continued on well but settled for the minor award. CAPTAIN VON TRAPP was close up along the inside, worked his way off of the rail into the lane, loomed a danger but failed to make headway. EVERFAST was forwardly placed between horses four wide, was within striking distance entering the stretch but lacked the needed late response. FROLIC MORE tucked in leaving the chute to save ground, got through into the stretch, tipped out for the final furlong and finished with a mild gain. DUNPH broke in and bumped MR MONEY BAGS at the start, was close along the inside to the stretch and tired. INSTAGRاند was hung wide outside MR MONEY BAGS into the turn, came up empty between horses before going six furlongs and retreated. LAST JUDGMENT was hung widest outside MR MONEY BAGS into the turn, faltered before going six furlongs and faded. DURKIN'S CALL was unhurried along the inside, swung wide entering the stretch and made a belated improvement. TOBACCO ROAD settled off of the inside and lacked a response. MANNY WAH prompted the pace three deep through the turn and caved. MR MONEY BAGS bumped with DREAM MAKER at the start and had the outside rein break, sprinted clear well off of the inside, set cracking fractions through the opening half, was well handled as he faded back through the field and avoided major issues.
