1 MILE. (Turf) (1.313) STAKES. Purse \$100,000 *PEBBLES S. FOR FILLIES THREE YEARS OLD.* No nomination fee. A supplemental nomination fee of \$1,000 may be made by time of entry. \$500 to pass the entry box and an additional \$500 to start, with \$100,000 added. All starters including supplements will be required to pay entry and start fees. The added money and all fees to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. 123 lbs. Non-winners of a Graded Sweepstakes on the turf in 2009 allowed 2 lbs.; a Graded Sweepstake, 4 lbs.; a Sweepstake on the turf; or two races on the turf, 6 lbs. (Maiden, claiming and restricted allowance races not considered). A trophy will be presented to the winning owner. The New York Racing Association reserves the right to transfer this race to the Main Track. Closed Saturday, September 26, 2009 with 33 Original Nominations and 1 Supplement. (If the Stewards consider it inadvisable to run this race on the turf course, this race will be run at One Mile on the main track.). (Cloudy 53)

MISS CATALYST pressed the pace three wide for six furlongs, opened a clear advantage in midstretch, battled into deep stretch and was fully extended to hold off PUL DANCER in the final strides. PULL DANCER raced in the middle of the pack between horses, saved ground midway on the turn, swung five wide for room at the quarter pole, split horses entering the stretch and closed strongly between horses but could not get up. MARAM was outrun for a half after breaking slowly, moved out on the turn, advanced five wide at the quarter pole and rallied belatedly in the middle of the track. LEGALLY BLANCA raced in hand between horses, raced in traffic leaving the turn, altered course outside in upper stretch and finished willingly. DYNASLEW raced in midpack from outside for a half, rallied four wide to reach contention nearing the quarter pole and flattened out. MY MAGIC MOMENT trailed to the turn, swung six wide at the quarter pole and finished evenly. MISS BLAKELY pressed the pace in the two path to the top of the stretch and steadily tired thereafter. BLUSHING DIXIE dueled along the rail into upper stretch and gave way. DENOMINATION was well in hand, steadied along the inside on the backstretch, saved ground while boxed in on the turn, advanced along the rail at the quarter pole and steadied along the inside while lacking room through the stretch run.
