The winner to receive \$120,000 with \$40,000 to second, \$ 22,000 to third, \$12,000 to fourth and \$6,000 to fifth. Weights, Tuesday, July 1, 2014. Starters to be named through the entry box by the usual time of closing. (Highweights on the scale preferred). Nominations closed Tuesday, June 24, 2014 with 31. A trophy will be presented to the winning owner, trainer and jockey. In the event that this race is taken off the turf, it may be subject to downgrading upon review of the American Graded Stakes Committee. (Hazy 88)

GAME FAIR saved ground while well placed, split rivals in early stretch and gained place. ALAURA MICHELE saved ground just off the pace, came up empty. NELLIE CASHMAN stalked the pace outside winner and weakened. APPEALING CAT raced wide, drifted wider into stretch and flattened out. EFFIE TRINKET, two wide under rating, fell back a bit on the far turn and never threatened. REMEMBER THEN failed to menace. ROCKINONTHEWATER steadied leaving the chute.
