All starters including supplemental nominees will be required to pay both entry and starting fees. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finishers. Any horse that competes in both the With Anticipation stakes at Saratoga and the Pilgrim will have their subscription fees waived for the Pilgrim stakes. 122 lbs. Non-winners of a Sweepstakes on the turf, 2 lbs.; a race other than maiden or claiming, 4 lbs.; a race on the turf, 6 lbs. Winners preferred. A trophy will be presented to the winning owner. The New York Racing Association reserves the right to transfer this race to the Main Track. **Bay Colt, (Apr), by Shakespeare - Tricky Mistress by Clever Trick. Trainer Shivmangal Doodnauth. Bred by Guilherme Bombonato & Angela Bombonato(FL).**

**SHKSPEARE SHALIYAH** brushed at the start, contently brought up the back of the pack, was placed in the three path for the run around the far turn, spun five wide into the stretch and took off in earnest after the front runners, was the widest of five challenging for control at the eighth pole, out kicked the other four under a brisk hand ride to prove best. **KITTEN'S KID** was bumped after bobbling at the start, was well reserved from off the hedge in midpack, proceeded around the second turn, wedged in between opponents with the rider atop with a firm hold on the reins, was forced to await options for a sixteenth, commencing from the five-sixteenths pole, turned for home and gained sufficient racing clearance soon afterwards, split rivals coming to the eighth pole to grab a slim and short-lived lead, with several others bearing down hard, proved no match for the winner, but dug in with good determination to preserve the place. **FANTASTIC SONG** was brushed at the start, sat forwardly placed, mostly three wide on the first turn and four wide on the subsequent one, was called upon entering the lane, bid between foes in midstretch for the lead and although never seizing it, continued onward gamely to earn the show. **CAPTAIN WEBB** vied from the two path, fighting against the bit throughout the run around the first turn, and periodically down the backstretch as well, came under heavy pressure after turning for home and succumbed. **KNOCK ROCK** was taken back after breaking near the top, was rated in the pocket until the quarter pole, got unleashed with clear passage awaiting him at that station, kept up the bid for an additional furlong before flattening out. **FOX RULES** bumped at the start, accompanied the leader from the outside, continued along the same scenario for nearly three-quarters and gave way.
