ON FIRE BABY tucked in to save ground, was well placed off of the pace, got through entering the stretch, shifted to the outside of AUBBY K inside the furlong marker, forged command and held AND WHY NOT at bay. AND WHY NOT was unhurried into stride, lagged well back near the tail of the field, commenced a long drive circling seven wide, finished full of run but was unable to reach the winner. GLINDA THE GOOD attended the pace off of the inside, worked her way to the outside for the final furlong, loomed a danger but lacked the needed late response. AUBBY K disputed the pace three wide, fought on through a prolonged drive, but weakened late and gave in. GOLDEN HISTORY settled in the second flight, came five wide and improved position. BELIEVE YOU CAN was hustled along five wide, drew even leaving the turn, but flattened during the drive. TAXI DANCER was unhurried into stride, moved up four wide on the turn, angled in entering the stretch and finished with a mild rally. FLASHY LASSIE dropped far back, angled out to make a belated gain but was never a threaten. HEART OF DESTINY was allowed to settle four wide and failed to respond. GEORGIE'S ANGEL stalked the pace, bid three wide between horses, but came up empty entering the stretch and retreated. MY DUE PROCESS vied along the inside, jumped tracks leaving the chute, kept on well through the turn and tired. BET TO WIN pressed the pace between horses to the stretch and stopped.
