PRIMO EXTREMO set the pace early, angled off the rail in the far turn and faltered late in the stretch run. UPSET BREWING was well placed early on, was on the inside entering the lane and weakened late in the stretch drive. SULTRY was reserved early on, shifted into the three path in the far turn and moved up in the stretch. HARBOR LIGHTS was never a real threat. FIRSTMATE was never a factor. SNOWFIRE fought restraint in the first turn and in the backstretch, was pocketed along the backstretch and was tired down the lane. TAKE CHARGE PAULA was bumped and bothered at the start, steadied inside the three eighths pole. VISION OF JUSTICE tracked the pace early, shifted into the three path in the far turn and was tired down the lane. LADY FREEDOM hopped at the start and was done early.
