LOOKIN AT LUCKY, between rivals entering the first turn, angled out four wide for the backstretch run, rallied four deep leaving the three furlong marker, moved to a short lead in upper stretch, dueled outside FIRST DUDE through the final three sixteenths and proved best under strong right handed urging. FIRST DUDE cleared under the wire the first time, set the pace under a light hold inside, was joined by rivals leaving the far turn, dueled under a vigorous ride into the lane, was overtaken soon after then continued gamely inside the winner while drifting out late. JACKSON BEND came in at the break putting YAWANNA TWIST in tight, gained a forward position along the rail entering the clubhouse turn, chased the dueling leaders into the stretch, angled out for room with three sixteenths to go then finished with good energy between rivals. YAWANNA TWIST, in tight at the break, angled in nearing the first turn, was lightly steadied near the seven furlong marker, advanced inside into the far turn, eased out and moved between foes mid way on the final turn, shifted out five wide for the stretch run, made a menacing move approaching the furlong marker but could not sustain his bid. DUBLIN bore out at the break then steadied to avoid the outrider, recovered and moved to the inside nearing the wire the first time, lagged well back for six furlongs, angled out five wide for the drive and finished with interest. PADDY O'PRADO lost ground four wide while in mid pack, was put to a strong ride three furlongs out, steadied briefly leaving the three sixteenths marker when appearing to get out then lacked any further response. CARACORTADO, within range early while three wide, moved in tandem inside the winner leaving the far turn, dueled on near even terms a quarter mile out, held well to the eighth pole then surrendered. SUPER SAVER was angled outside FIRST DUDE before the wire the first time, prompted that rival two wide, moved to challenge leaving the far turn, dueled between rivals to the quarter pole, gave way and steadied when in tight leaving the three sixteenths marker. SCHOOLYARD DREAMS, bumped at the break, was taken in hand to rate early while off the rail, moved up between rivals nearing the half mile marker, made a threatening four wide run approaching the quarter pole then lacked a further response. AIKENITE lacked speed, came five wide for the drive and failed to reach contention. PLEASANT PRINCE, pinched back at the break, settled back towards the inside, raced between rivals leaving the five sixteenths pole but failed to make an impact. NORTHERN GIANT broke outward then steadied when put in tight when JACKSON BEND came over, angled to the inside in early backstretch, made a mild run nearing the far turn then tired after seven furlongs.
