By subscription of \$300 each which should accompany the nomination; \$1,500 to pass the entry box and an additional \$1,500 to start. For horses not originally nominated, a supplemental payment of \$3,000 along with the entry and starting fees may be made at any time prior to the closing of entries. The purse to be divided 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally amongst the remaining finishers. 122 lbs. Non-winners of a Graded Sweepstake twice allowed 2 lbs.; of a Sweepstake other than state bred in 2016, 4 lbs.; of \$60,000 or two races other than maiden, claiming, starter or state-bred allowance races allowed 6 lbs. Trophies will be presented to the winning owner, trainer and jockey. Closed Saturday, August 20, 2016 with 18 Nominations. (Clear 80)

LUCY N ETHEL emerged from a cluster of equines shortly after the start hooked up in a tussle with CONIAH, had that rival back off coming to the conclusion of the backstretch, wasn't left alone too long though with the runner up ranging up to apply pressure to her outside in short order, spun into the stretch, with the nemesis latched on, was in the vicinity of the three-sixteenths marker when given her cue, responded positively, dug in gamely in the final furlong to fend off the second place finisher. DEAREST was sent into the two path proceeding along the backstretch, steadily chopped away at the deficit, arrived at the head of the stretch side by side with the winner, got asked for her best after a couple of more jumps, finished with good determination under a strong drive, but couldn't go by. TAKREES made it over to the rail well before reaching the half mile pole, brought up the rear, devoid of any semblance of speed, came to life as the half was being completed, entered the stretch angling to the outside and under a drive, began the final furlong approximately six wide, rallied with a belated rush to earn the show award. OFF THE TRACKS reserved in the two path for nearly a half, tipped wider late on the turn in preparation for the turn for home, was eventually urged four wide into the lane, rallied midly. KAREENA travelled from the three path on the turn, began the last eighth one farther off the rail, lacked the needed response. CONIAH disputed the pace matched up with the top one for most of the trip along the backstretch, was taken back a short distance from the half mile pole, tracked the winner within striking distance, got asked for run angling two to three wide into the lane, made no gain. ONE TRUE KISS broke out sharply, was corrected but not before bumping hard with its next door neighbor, went two wide on the turn, got driven into path five from upper to midlane, made no impact. LOST RAVEN struck the left side of the gate, underwent a ground-saving journey, cut the corner into the lane and came up empty. COPPA quickly tucked along the inside, saved ground to the quarter pole, failed to fire after being angled out at the top of the lane. APPEALING MAGGIE bumped soundly with ONE TRUE KISS at the start, pursued the pace three wide on the turn, was six wide by midstretch, tired.
