1<sup>1</sup>/<sub>4</sub> MILE. (1:46<sup>3</sup>) STAKES. Purse \$300,000 Prairie Meadows Cornhusker H. (Grade III) FOR THREE-YEAR-OLDS AND UPWARD. No nomination fee. \$2,000 to pass the entry box and \$3,000 additional to start. \$300,000 guaranteed which will first be reduced so as to allow \$500 to be paid to each of the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, 2% to sixth. SUPPLEMENTAL NOMINATIONS AT A FEE OF \$300 BY SUNDAY, JUNE 23. Weights: Wednesday, June 26. Starters to be named through the entry-box by the usual time of closing. This race will not be divided and if the entry number exceeds fourteen (14), preference will be given to Breeders' Cup nominees only of equal weight assignment. Different owners will have equal draw according to weights. The second parts of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees. (Clear 80)

SIR ANTHONY settled well, made a strong four wide bid on the far turn, responded to pressure and rallied while four wide in the stretch. DARK VADER chased while three wide, moved closer on the far turn and finished willingly in the stretch. REMEMBERING RITA stalked the early pace, dueled up the back stretch run and around the far turn, forged clear into the stretch, was collared and bore out late under left-handed pressure. HENCE void of speed, commenced his bid on the far turn, was swung five wide for the stretch run and offered a bid. POPULARITY raced forwardly while four wide and lacked a rally. RETIREMENT FUND saved ground, was angled off the rail into the stretch and gave no response. EXCLAMATION POINT was outrun early and failed to threaten. EXULTING reserved three wide, advanced on the far turn and flattened out. CHRIS AND DAVE raced in striking position and weakened. PINSON contested the early pace and retreated at the three-eighths pole.
