Non-winners of \$60,000 at one mile or over allowed 2 lbs.; \$45,000 at one mile or over, 4 lbs.; two races other than claiming at one mile or over, 6 lbs. Highest total earnings at time of entry have preference. A trophy will be presented to the owner of the winner. (Clear 73)

Chestnut Filly, (Apr), by City Zip - Stormbow by Storm Cat. Trainer Hollendorfer Jerry. Bred by Dr. D. Michael Cavey Jr.(KY). CITY TO CITY chased outside a rival, came out on the second turn and five wide into the stretch, rallied under some left handed urging and strong handling to gain the lead in deep stretch and gamely prevailed. ANDINA (IRE) pulled a bit between foes then chased alongside a rival, came out leaving the second turn and four wide into the stretch, split horses in the drive, also drifted in and continued willingly to the wire. IN THE SLIPS angled in and settled off the pace inside, swung out into the stretch and finished well for the show. CAMILLE C pulled her way to the front outside a rival, angled in and set the pace inside, kicked clear in the stretch but weakened late. WARREN'S SKATER pulled between foes then stalked inside, came a bit off the rail for room in the stretch and lacked the needed late kick, then broke down and fell while pulling up into the clubhouse turn. WARREN'S JITTERBUG three deep into the first turn, stalked outside a rival, came three wide into the stretch and could not summon the necessary response. COZI ROSIE saved ground chasing the pace, got through along the rail in midstretch then was in tight a sixteenth out. ANTARES WORLD pulled her way along inside early, split horses on the backstretch, came out into the stretch and did not rally. PULPIT MAGIC stalked three deep then outside a rival, was between horses into the stretch and weakened. HOT CITIZEN settled between horses then three deep, dropped back on the second turn and gave way.
