FAULT tracked the pace on the inside the whole way, angled out at the eighth pole into the four path and rolled from there while drifting in. JOURNEY HOME tracked the pace on the outside going three wide around the turn, maintained her position through the backstretch then turned for home in the three path but swung very wide at the top of the stretch with a rally, had a brief lead at the eighth pole and brushed with CANNY at the sixteenths, continued the lead until she got sniped on the line by the winner. LOVELY BERNADETTE went around the first going two wide while running in the middle of the pack, turned for home going three wide but had to go even wider at the top of the stretch where she popped off a late rally. CANNY chased the pace on the outside going two and three wide around the turns, vied for the lead at the eighth pole but could not get there, got brushed by JOURNEY HOME at the sixteenths pole then folded up. PRINCESS LA QUINTA hit the gate at the start when he ducked out, recovered and got up to chase the pace in the two path then ran very gamely through the finish but did not have enough. DONTMESSWITHJOANNE was quick to angle in after the start to snag a spot on the rail, lost action briefly near the half mile pole but was unfazed, turned for home going two wide and had was no match. SENSITIVE ducked out at the start but quickly got into stride, took the rail around the first turn then stayed well rated up the backstretch, went wide turning for home then had a mild rally. LIPSTICK CITY hit the gate at the start then ran towards the rear in the two path, stayed at the back even into the stretch then lost action as she went over the tracks left by the gate and finished evenly from there. HAPPY MESA ran towards the rear going three wide around the turns, swung very wide into the stretch and finished evenly. KATINKA hit the gate at the start but recovered to get up and push the pace in the four path, kept he pressure on turning for home but lacked a rally. MO'S M V P hit the gate at the start then recovered to settle in the middle of the pack, went three and four wide around the turns swinging even wider at the top of the stretch where she had no response. ROYALTY PRINCESS was under a snug hold in the early going while rounding the first turn in the three path, set a pressured pace until she stopped at the three sixteenths pole.
