that bend, was unhurried near the back, moved closer alongside ANGELE RENEE with a half-mile to run, advanced three then four wide on the

far turn, rallied under a drive while outside in upper stretch, closed fast to get the lead outside the furlong marker then edged clear under strong urging. LOVELY MARIA was restless in the gate, went three wide on the first turn, stalked the pace, made a bid while three wide on the far turn,

dropped to the two path turning into the stretch, battled under a right-handed whip into the final furlong, had the rider lose the whip at the sixteenth-pole and was outfinished while just able to get the place. FOREVER UNBRIDLED brushed with FREUDIE ANNIE at the start, went

four wide on the first turn, was forwardly placed on the outside, ranged up while four wide on the far turn, made a bid at the five-sixteenths pole,

dropped to the three path turning into the stretch, battled into the final furlong under a drive and was also outfinished then missed the place.

ANGELA RENEE was a bit sluggish early, raced inside on the first turn, lagged at the rear, moved closer under urging at the half-mile pole, went

two then three wide early on the far turn, moved to four wide late on that bend, came five wide into the stretch and finished willingly to just miss the

show. SHOOK UP was rated while off the pace, came under urging while two to three wide on the far turn, chased under a drive in upper stretch and

weakened. WEST COAST BELLE went three then two wide on the first turn, settled in the back half of the field, was urged along while four wide on the far turn and failed to rally. WHITE CLOVER was restless in the gate, moved up along the rail to take the lead into the first turn, set the pace on the inside, was urged along on the far turn, dropped out outside the guarter-pole and gave way. PLEASANT TALES prompted the pace on the outside of the leader, was urged along between horses on the far turn, dropped out outside the quarter-pole and faded. HARBOUR ISLAND went four then three wide early on the first turn, dropped to the rail late on that bend, settled near the middle of the field, moved closer with five

furlongs to run, was urged along while inside on the far turn and stopped. FREUDIE ANNE brushed with a rival at the start, lugged out into the first

turn, went four to five wide on that bend, settled on the outside, dropped to the rear leaving the backstretch and was pulled up then walked off.
