WITTY chased off the rail then inside, moved up leaving the turn, came out approaching the stretch, bid alongside the runner-up in the stretch, gained the lead past midstretch and proved best under some urging. CARLSBAD pulled a bit early, set a pressured pace a bit off the rail then inside, inched away into the turn, fought back inside in the stretch, could not match the winner but held second. WILL O WAY settled off the pace inside, came out into the stretch and just missed the place. ULTRA BLEND bobbled at the start, chased between foes then a bit off the rail, angled in leaving the turn and lacked the needed late kick. STRAWBERRY TART had good early speed and pressed the pace outside CARLSBAD, stalked off the rail on the turn, was outside the winner leaving the turn and three deep into the stretch, then weakened. BURG BERG chased three deep then off the rail, angled in some on the turn and did not rally.
