1 MILE. (1:33) STAKES. Purse \$100,000 Rampart S.FILLIES AND MARES, THREE YEARS OLD AND UPWARD. Free nomination by Sunday, November 29. \$1,000 to enter and \$500 to start, with all starters to receive a \$500 rebate in addition to the purse. \$100,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. Weight: Three Year Olds: 120. Older: 123 lbs. Non-winners of a graded stake at a mile or over since June 1 allowed 2 lbs.; a sweepstakes at a mile or over since June 1, 4 lbs.; three races other than maiden, claiming, or starter, 6 lbs. Starters to be named through the entry box by the usual time of closing. Supplemental nominations may be made at the time of entry. All fees shall be paid prior to the start of the race. This race will be limited to 14 starters, with also eligibles. If more than 14 entries pass the entry box, preference will be given to graded stakes winners, then highest career earnings. Trophy to the winning owner. (Clear 81)

Chestnut Filly, (Apr), by Street Cry (IRE) - Graeme Six by Graeme Hall. Trainer Martin D. Wolfson. Bred by Besilu Stables, LLC (KY).

CALI STAR was well placed rated just off the top flight in the backstretch, saved ground along the inside, moved up along rail to challenge BEST BEHAVIOR for the lead, urged right handed, took over and pulled away. BEST BEHAVIOR raced on top out of the chute then sat just off PINK POPPY and forced early pace, edged up at half mile marker and vied for lead along the outside, continued to dig in running around far turn, challenged by eventual winner at the quarter pole, could not move on with rival but continued solid bid to secure place. STIFFED trailed the field in the backstretch, continued reserved running in the far turn, swung out six wide entering the head of the lane and quickly gained ground to capture show. MOMENT OF DELIGHT was placed in good position rated off top flight racing off the top trio, came under ride midway in the far turn, continued three wide bid in the lane, finished evenly in late drive. DANESSA DELUXE was allowed to settle in the backstretch, went in pursuit at five sixteenths pole, swung into action five wide entering top of the lane, gained position then evened out. LEGAL LAURA pressed the pace in opening stages, edged up and vied for lead at the half mile marker, continued to battle between then along outside of BEST BEHAVIOR, could not keep up pace at quarter pole and steadily weakened. CURLIN'S PRINCESS stalked the top flight in the backstretch, hustled up and raced in contention in the far turn, could not continued bid into lane and gateway. PINK POPPY moved up to take slight lead coming out of the chute, vied for lead along inside of rivals at the half mile, could not match strides in far turn and faded in the lane.
