(GRADE III) FOR FILLIES AND MARES, THREE-YEAR-OLDS AND UPWARD.* By subscription of \$150 each, which shall accompany the nomination, \$2,250 additional to start, with \$150,000 Guaranteed, of which \$90,000 to first, \$30,000 to second, \$18,000 to third, \$9,000 to fourth and \$3,000 to fifth. The Rancho Bernardo Handicap has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The winner of the Rancho Bernardo Handicap will be entitled to automatic entry into the 2010 running of the Breeders' CupFilly & Mare Sprint, subject to the payment of all pre-entry, entry and supplementary (if applicable) fees. To be eligible for the 2010 Breeders' Cup Championships to be held at Churchill Downs on November 5-6, 2010, all horses must be pre-entered by noon (local time at the designated pre-entry locations) by October 25, 2010. All applicable fees shall accompany the pre-entry. Weights Sunday, August 15. High weights preferred. A trophy will be presented to the owner of the winner. Nominations closed Thursday, August 12, 2010 with 13. (Clear 76)

SWEET AUGUST MOON three deep early, stalked off the rail then outside a rival, bid alongside the runner-up on the turn and into the stretch, took a short lead under urging in midstretch and was inching away late under good handling. ALPHA KITTEN went up inside to duel for the lead, inched away and came off the rail leaving the backstretch, angled in on the turn, came a bit off the fence again into the stretch, fought back inside the winner through the final furlong and held second. SILVER SWALLOW chased off the rail, came out in upper stretch and finished with interest. TASTE'S SIS had speed just off the inside early, dueled outside the runner-up, angled in early on the turn and stalked the pace but weakened in the stretch.
