CHALON set the pace early from the four path, shifted into the three path entering the lane, was under a long drive in the stretch and finally gave in during the final stages. TORRENT chased the pace early along the eight path, was in the six path entering the lane, made a bid in the stretch and was gaining in the late stages. TEQUILITA was unhurried early from the five path, altered to off the rail entering the lane, rallied in the stretch and just missed show in the late stages. NONNA MELA was well placed early along the five path, shifted into the four path in the turn and flattened out late in the stretch run. CLASSY TUNE was back early along the nine path, was in the five path in the turn and moved up in the stretch drive. HAPPY MESA trailed the field early on, fanned into the seven path in the turn and leveled out down the lane. PRETTY CITY DANCER stalked the pace early from the six path, shifted into the four path in the turn and faded late in the stretch. PINCH HIT was never a threat. OVERTURE had early speed then folded up.
