The Host Association's monies divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, and 2% to be divided equally between remaining starters. Breeders' Cup Fund monies also correspondingly divided providing a Breeders' Cup nominee has finished in an award position. An y Breeders' Cup Fund monies not awarded will revert back to the Fund. WIN WILLY steadied past the wire the first time when in tight, raced back, asked for some run midway in the second turn, made a nice move into contention four wide turning for home, finished full of run to win going away. SPOTSGONE broke on top, set the pace under mild restraint, got a breather into the far turn, continued to show the way by daylight into the lane, proved no match for the winner, held sway for the place. GONE ASTRAY stalked the pace on the outside while in hand and four wide for five furlongs, moved toward the inside a bit to be three wide entering the stretch, flattened out, came back for the show. PROM SHOES fell far back to trail, swung out five wide when advancing exiting the final turn, outfinished for the show while remaining well outside. JONESBORO forwardly placed and in good position along the inside, continued to race within striking distance into the lane, came up empty when the real running started at the head of the lane. RACING BRAN within striking distance on the outside, for six furlongs, firmly rated, also failed to respond when called on in the drive. ACTING ZIPPY lugged in at the start, had nothing left for the drive. MAD FLATTER prompted the pace while three wide much of the way for the first six furlongs, gave way in the drive.
