CYBER SECRET in some early traffic, reserved off the pace, moved out, three wide when advancing turning for home, long and spirited drive, up in the final strides to prove best in determined fashion. GOLDEN RON broke well, got clear before a quarter, set the pace in the two path, continued to show the way into the lane, dug in between rivals and proved stubborn until the end. ATIGUN in some traffic into first turn well in hand, remained under firm restraint in the run up the backstretch, squeezed through inside the runner up to challenge turning for home, raced on equal terms with the top two past the furlong marker, stubborn. BRETHERN forwardly placed, between foes when close into the lane, could not hang with the top three in the drive. ALTERNATION lacked speed, five wide in the first turn, continued to race outside, five wide again in the second bend, showed some belated interest down the middle of the strip after the issue had been decided. SAN PABLO settled in mid pack while well off the rail, remained off the inside the middle half, three wide into the lane, lacked a late kick. NAJJAAR lacked speed, made little impact. DONOHARM well off the pace, did not fire. RIDE THE LIGHTNING off slow, trailed early, improved the middle half, backed up in the drive. RAISON D'ETAT off slow, trailed most of the way, well beaten.
