NO SUCH WORD was allowed to settle in stride while in hand from start, moved up outside rivals willingly during run down backstretch, forced four wide into stretch, went unchallenged while under a hand ride to wire. AMERICAN STORY dueled for lead along rail from start, responded to gain narrow edge at the half, no match for winner when challenged into stretch, but held on to be second best. SPEEDACIOUS stalked leaders along inside from outset, drifted outward three wide into stretch, tired in drive. JOY'S PARADISE forwardly positioned along rail from start, moved up to loom danger entering stretch, gave way in lane. THE RUMOR'S TRUE failed to menace. EYES OF A SAINT well back at the half, never a factor. DIXIELAND BABY raced in middle of pack into stretch, lacked response. MANDIRA stalked leaders for half, faded. GOLDEN STRIKER was never a threat. MACHORINA stumbled forwardly at the break, rushed to front, quit after half.
