Purse \$200,000 (Includes \$50,000 BC - Breeders' Cup) *RICHTER SCALE SPRINT H.(GRADE II) FOR FOUR YEAR OLDS AND UPWARD.* By subscription of \$200 each by Thursday February 28,2008 which shall accompany the nomination, \$1,500 to pass the entry box and \$1,500 additional to start, with \$150,000 Guaranteed and an additional \$50,000 from the Breeder s' Cup Fund for cup nominees only. The host association monies to be divided 60% to the owner of the winner, 20% to second, 11% to third, 6% to fourth, 3% to fifth, Breeders' Cup Fund Monies not awarded will revert back to the fund. Weights: Monday, March 3, 2008. This race will not be divided. The field will be limited to 14 Starters. If more than 14 entries pass the entry box by Wednesday March 5,2008, the starters will be determined at the time with preference given to Breeders' Cup Nominees only of equal racing quality or weight assignment (respective of sex and weight for age). Trophy to winning Owner given by Breeders' Cup. Ltd. (High Weights Preferred). All fees shall be paid prior to the start of the race. (Clear 74)

COMMENTATOR showed speed outside ELITE SQUADRON while in hand, moved to gain the lead from that rival on the turn, then drew off through the stretch under a hand ride. REXSON'S ROSE chased the pace three wide around the turn but was no match for the winner while continuing on with good courage to gain the place. ELITE SQUADRON showed speed along the inside to nearing the stretch, then tired. GRAND CHAMPION was not a factor. STEVE'S DOUBLE reserved along the inside, steadied from tight quarters leaving the turn and faltered. NYUK NYUK NYUK off slowly, moved up to chase the pace around the turn, then faded.
