KEEP UP unhurried for a half while outrun, advanced three wide into the second turn, swung out eight wide entering the stretch and closed fast on the outside to be up in time. BOISTEROUS within striking distance along the inside, moved closer on the second turn, angled of the rail for the drive, gained a short lead between rivals with a furlong to go and held on gamely. SKYRING closest to the pace off the inside, was patiently handled to the stretch, challenged with a furlong to go and also held on gamely. SWIFT WARRIOR prominent four wide, moved out a path late on the second turn when rallying, reached a forward position with a furlong to go but lodged only a mild late bid. OPTIMIZER unhurried early, moved up inside after six furlongs, reached a striking position once in the stretch, lacked a clear path from the furlong marker to the final sixteenth, worked his way out and finished willingly late. MIAMI DECO reserved three wide, angled out six wide leaving the second turn but lodged only a mild late bid. MIDDIE outrun for six furlongs along the inside, angled out a bit for the drive but made only a mild gain. GUYS REWARD within reach off the inside, came three wide into the stretch and lacked a late bid. GLOBAL POWER set the pace along the inside, held on well to the final furlong and tired. DEPECHE CHAT close up early four wide, dropped back before a half, raced seven wide with a quarter mile to go and tired. TEMERAINE fractious in the gate, was far back to the stretch and made a belated bid. STORMY LORD close up three wide, moved out a path entering the stretch and stopped.
