SPEEDINTHRUTHECITY pulled to contention off of the inside, was bottled up through the turn to the final furlong, worked her way to the outside, and quickly drew away once uncovered. ANAHAUC attended the pace four wide, moved up to join the vanguard midway through the turn, forged command a furlong out but was no match for the winner. DEVIOUS D'ORO broke a step slow, was unhurried into stride, took closer order through the turn, angled out five wide entering the stretch, was floated out a bit further by the winner, but kept on fairly well to earn the show. WARM BREEZE tracked the pace three wide, but weakened between horses during the drive and gave way. BLUEEYESINTHEREIN contested the pace along the inside, but flattened in the final furlong and faded. TURN BY TURN set the pressured pace between horses to the stretch and retreated.
