1 $\frac{1}{8}$  MILES. (1.42<sup>2</sup>) STAKES. Purse \$100,000 *RUSHAWAY S. FOR THREE-YEAR-OLDS*. No nomination fee. \$500 to enter and \$500 additional to start. Supplementary nominations may be made at the time of entry Wednesday, March 18, 2009 by payment of \$5,000 each (includes all fees). \$100,000 Guaranteed. After payment of 1% to all owners of horses finishing 6th through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 121 lbs. Non-winners of a Sweepstakes at a mile or over allow ed, 2 lbs.; A Sweepstakes, 4 lbs.; a race other than maiden or claiming at a mile or over since January 1, 6 lbs. Starters and riders must be named through the entry box by the usual time of closing. This race will be limited to twelve starters. Preference to start will be given in the following order: Graded/Group Stakes winners (in order I-II-III), stakes winners, then highest career earnings. All Lane's End nominees are automatically nominated to this race. Failure to draw into the race cancels all fees. Closed Wednesday, March 11, 2009 with 22 Nominations. (Clear 58)

**Dark Bay or Brown Colt, (Apr), by The Cliff's Edge - Future Act by Known Fact. Trainer Miller Darrin. Bred by Bruce T. Hundley(KY).**

CLIFFY'S FUTURE was reserved early, angled into the five path inside the quarter pole then rallied in the stretch and drove past the leaders while clearing late under a steady drive. ZIEGFELD was unhurried early, swung widest into the lane and got up for place late while no match for the winner. TOCCEt ROCKET was back early, angled into the four path entering the lane and moved up in the stretch run. SUNDAYS BABY GRAND tracked the leader early then took over the lead briefly, angled into the three path inside the quarter pole and gave way in the stretch drive. NO INFLATION was well placed early, angled into the four path into the far turn then led in the stretch but faltered late in the final stages. FITZASLEW pressed the pace early then led the field briefly, angled off the rail into the far turn and faded late in the drive. SUMMER'S EMPIRE raced up close early, angled into the four path inside the quarter pole and was tired down the lane. NINTH CLIENT showed early speed then soon retreated.
