By subscription of \$100 each, which should accompany the nomination, \$1,000 to pass the entry box and \$500 to start. The owner of the winner to receive \$60,000, \$20,000 to second, \$10,000 to third, \$5,000 to fourth, \$3,000 to fifth and \$2,000 to sixth through last. Three-Year-Olds: 117 lbs.; Older: 123 lbs. Non-winners of \$60,000 twice at a mile or over in 2018 allowed 2 lbs.; a graded stakes in 2018, 4 lbs.; \$50,000 since March 1, 2018, 6 lbs. The winning owner to receive a trophy. Closed Saturday, May 12, 2018 with 23 nominations. A \$4,000 supplemental nomination, which included all fees, was made at time of entry, Wednesday, May 23, 2018. (Clear 85)

PAGE MCKENNEY saved ground racing off the pace, advanced inside on the far turn, came wide into the stretch, closed strongly outside in deep stretch and was up late for the win. SHAFT OF LIGHT set the pace on the inside, moved off the rail turning for home, dug in gamely when challenged, turned back a bid SUNNY RIDGE, edged away and was caught in the final strides. SUNNY RIDGE stalked two wide, bid two wide on the far turn, rallied outside turning for home, dug in gamely outside of SHAFT OF LIGHT in midstretch and then was outkicked. CHIP LEADER raced three wide early, then stalked outside, came four wide into the stretch and weakened. PAPA ZULU raced off the pace inside, advanced inside on the far turn and failed to rally. GREAT STUFF was off slowly, raced off the pace outside a rival and did not factor. INDIAN GUIDE raced off the pace inside and gave way on the far turn.
