GLADDING took the early lead and set the pace inside, dueled on the backstretch, briefly inched away again on the second turn, responded when challenged again leaving that turn and through the stretch and came away from the runner-up under urging in deep stretch to prove best. SPURRIER broke in and a bit slowly and steadied, settled inside, came out leaving the backstretch, advanced four wide then three deep on the second turn, bid outside the winner leaving that turn and in the stretch but could not match that one late while clearly second best. AGGIE ENGINEER was in a good position stalking the pace outside then three deep, came out into the stretch and held third. QUINDICI MAN stalked a bit off the rail then inside on the backstretch and second turn, came out into the stretch and lacked the needed late kick. BIG SHOT SYD pulled his way along to stalk the pace just off the inside then between foes, angled in leaving the second turn and could not offer the necessary response. PODE IR (BRZ) stalked early then prompted the pace outside the winner, fell back some on the second turn, came out into the stretch and weakened.
