CALIFORNIA CHROME pulled his way between horses in the run to the first turn, stalked just off the rail, bid outside the pacesetter to gain the advantage into the second turn, inched away, fought back past midstretch, could not match the winner in the final sixteenth but was clearly second best. HOPPERTUNITY stalked the pace inside, split horses into the second turn, bid along the rail leaving that turn and into the stretch and held third. BRONZO (CHI) four wide into the first turn, chased outside then three deep on the backstretch and into the second turn, came three wide into the stretch and was edged for the show.
