EDEN'S MOON had speed between foes early, angled in and set a pressured pace inside, inched away leaving the backstretch, came off the rail in the drive, kicked clear and proved best under a crack of the whip and good handling. OPEN WATER saved ground chasing the pace, came out into the stretch then continued along the fence in the drive to be second best. INDIGO RIVER (IRE) angled in and chased outside a rival, came out off the rail some in the stretch and bested the others. BYRAMA (GB) broke slowly, settled inside, came out into the stretch and again nearing midstretch and improved position. KILLER GRACES chased off the rail then outside a rival, came three wide into the stretch and lacked a rally. DONTGETMADELEXIS three deep early, pressed the pace outside the winner then stalked a bit off the rail into and on the second turn, had the rider lose the whip in midstretch and weakened. OBLIVION had speed inside then saved ground stalking the pace to the stretch and also weakened.
