GIACOMO unhurried a bit off the rail early, came out leaving the second turn and four wide into the stretch and rallied under steady left handed urging to get up in the final stride. PREACHINATTHEBAR sped to the early lead, set a pressured pace inside, inched away into the stretch, got clear and held on well but was caught on the line. PAPI CHULLO four wide into the first turn, chased outside, ranged up four wide leaving the second turn, came in entering the stretch, drifted in some in the drive and could not match the top pair. SOUTHERN AFRICA five wide early, angled in on the first turn, chased inside, inched forward on the second turn, waited briefly a quarter mile out, came out a bit for room in upper stretch, drifted in and lacked the needed rally. TEXCESS prompted the pace three deep, was between foes leaving the second turn, steadied in tight into the stretch and weakened. PUBLICATION allowed to settle off the rail, came out in the stretch and did not rally. RATHOR (IRE) sent between horses early, forced the pace between foes, steadied sharply in tight in upper stretch and weakened. Following a stewards' inquiry, PAPI CHULLO was disqualified and placed seventh for interference in upper stretch.
