CATCH A FLIGHT (ARG) chased three deep then outside a rival, continued off the rail on the second turn, came out in the stretch and rallied under urging to get up in the final stride. APPEALING TALE came out and dueled outside a rival, put a head in front on the backstretch, regained the advantage into the stretch, inched away while drifting out from the whip in deep stretch and was caught on the wire. BAYERN sped to the early lead, dueled inside, took a short lead again into the second turn, fought back inside in the stretch and held third. HOPPERTUNITY stalked inside then a bit off the rail, came out leaving the second turn and three deep into the stretch and just missed the show. SAHARA SKY settled off the rail then outside a rival, came out into the stretch and lacked a rally. SAMMY MANDEVILLE angled in and saved ground off the pace, came out into the stretch and did not rally. MAJESTIC CITY a step slow to begin, stalked between horses then a bit off the rail, angled in on the second turn and weakened in the stretch.
