SIDNEY'S CANDY gained command into initial turn, rated from along the fence to second turn, nudged and extended cushion into the stretch, kicked further away and safely held under strong late handling. INTERACTIF content to settle off the pace, secured the inside, stalked along the rail into second bend, came out some exiting that turn, battled CARACORTADO past midstretch then whittled gap on winner late under vigorous urging. CARACORTADO reserved off the pace, while angling over, moved up some into second bend, came four wide into the stretch, battled outside runner-up past eighth marker but failed to sustain rally late. AMERICAN LION was bit antsy in the gate, pulled his way up to prompt the pace into backstretch, stalked outside pacesetter, lost contact approaching the stretch and weakened from between horses. STEPHEN'S GOT HOPE unhurried leaving the gate, trailed from the inside, angled out three wide around the final bend, remained off the rail and failed to threaten. DAVE IN DIXIE reserved while outside rival, chased on same two wide path to second turn, drifted out some, came back in bit in the lane but lacked an effective late punch. ERBEIA hopped slightly and was slow to begin, settled along the rail, continued inside into the stretch and never menaced.
