1 1/4 MILE. (1:39) STAKES. Purse \$400,000 (Includes \$690 Other Sources. Pluses \$690 Other Sources.) San Felipe S. (Grade II) FOR THREE-YEAR-OLDS. By subscription of \$100 each to accompany the nomination, closed Thursday, March 1, 2018 with 6 or by supplementary nomination of \$8,000 at time of entry. \$3,000 to enter. \$3,000 additional to start, with \$400,000 Guaranteed. The winner to receive \$240,000 PLUS 50 KENTUCKY DERBY POINTS, \$80,000 (20 Points) to second, \$48,000 to third (10 Points), \$24,000 to fourth (Five Points) and \$8,000 to fifth. 124 lbs. Non-winners of a Grade I or Grade II stake at One Mile or Over allowed 2 lbs. Non-winners of a Grade III stake at One Mile or Over, allowed 4 lbs. *Early bird nominees to the 2018 Santa Anita Derby closed with 79, are automatically eligible to the San Felipe Stakes with all fees waived. A trophy will be presented to the winning owner. (Showery 61)

MCKINZIE had speed between horses then stalked off the rail, bid between foes again on the backstretch and outside a rival on the second turn, took a short lead leaving that turn, angled to the rail and bumped with BOLT D'ORO into the stretch, fought back under left handed urging through the drive, came out some under left handed whipping to bump that one again late and gamely prevailed. BOLT D'ORO pulled and stalked a bit off the rail, bid three deep leaving the second turn, took a short lead outside MCKINZIE while bumping with that one into the stretch, battled outside that foe through a stiff drive, was bumped again late and continued gamely to the wire. KANTHAKA bobbled, came in and bumped a rival at the break, settled off the rail then a bit off the fence, angled out three deep into the stretch and held third. PEACE broke out a bit and bumped a foe, settled off the inside, went around a rival on the second turn, split horses nearing midstretch then was edged for the show inside. AYACARA (GB) allowed to settle off the pace inside, saved ground, swung three deep into the stretch and lacked a further response. AQUILA had speed three deep to press the pace then stalked outside, bid again three wide on the backstretch, tracked outside then off the rail on the second turn and a bit wide into the stretch and weakened. LOMBO had speed inside then inched away on the first turn, set the pace inside, dueled along the rail on the backstretch and second turn, dropped back into the stretch and weakened. Following a stewards' inquiry into the stretch run and claims of foul by the rider of BOLT D'ORO against MCKINZIE for interference in upper and late stretch, the stewards disqualified the latter and placed him second for interference in late stretch.
