BY YOUR SIDE away well to briefly show the way, settled in pursuit three wide down the backstretch in closest aim of the leader, tucked to the

two path into the turn, came under coaxing at the five-sixteenths, swung three to four wide into upper stretch, rallied to take command a furlong from home, edged clear under a drive to prevail. TOMATO BILL broke in at the start under coaxing and bumped CUCINA, established the front

and showed the way in hand just off the inside until tucked inside half a mile from home, came under coaxing nearing the quarter pole, spun just off the inside into upper stretch, dug in under a drive shying out slightly under a near sided stick nearing the eighth pole, yielded the front at that station, dug in chasing the winner home shying in under an off sided stick and forced RAGING WHISKEY to briefly pause inside the sixteenth marker, then to steady with seventy yards to go when shutting the inside off and was along safe for the place honors. RAGING WHISKEY coaxed from the gate, chased along the inside coming under coaxing at the five-sixteenths, cut the corner into upper stretch, rallied up the inside and

briefly paused as TOMATO BILL shied in under an off sided stick just inside the sixteenth pole, then got forced to steady when his inside seam was sealed off as TOMATO BILL shied in once more seventy yards from the finish, lost momentum as a result and just held for the show honors. CUCINA bumped at the start by TOMATO BILL who broke inwards, chased two then three wide under coaxing from the five-sixteenths, angled

four to five wide into upper stretch, weakened in the late stages. MEMORABLE off to an awkward beginning, chased along the inside until tipped three to four wide placed to urging at the three-eighths, continued three to four wide at the quarter pole, weakened in the stretch. There was a Stewards' Inquiry into the stretch run as well as a Jockey's Objection by the rider of RAGING WHISKEY alleging interference against TOMATO BILL in the stretch. After review it was deemed that RAGING WHISKEY had not been cost a finishing position by the impediment. The objection was therefore dismissed and the result stood prior to the race being declared official.
