Closed Thursday, January 7th, 2010 with 20. Or by supplementary nomination of \$3,000 by time of entry. Closed with 1. \$1,500 additional to start, with \$150,000 guaran teed, of which \$90,000 to first, \$30,000 to second, \$18,000 to third, \$9,000 to fourth and \$3,000 to fifth. 122 lbs. Non-winners of \$200,000 at one mile or over since May 1 or \$90,000 twice at a mile or over since July 1 allowed 3 lbs.; non-winners of \$90 ,000 at a mile or over since July 1, 5 lbs.; two races other than maiden or claiming since September 1, 7 lbs. LOUP BRETON (IRE) bobbled at the start, angled in and chased inside then a bit off the rail, continued between foes on the second turn, came three deep into the stretch, waited off heels when boxed in passing the eighth pole, came out and bumped a rival then rallied under steady handling to gain the lead in late stretch. HIGH COURT DRAMA (IRE) stalked outside a rival, bid three deep into the stretch, gained the advantage three wide past the eighth pole and held on well but could not quite match the winner late. RIVIERA COCKTAIL chased alongside a rival then three deep into and on the second turn, came four wide into the stretch, was bumped by the winner in midstretch and continued willingly for the show. DYNAMIC RANGE angled in and chased inside then a bit off the rail, continued inside on the second turn, came out in upper stretch and just missed third. PEARL FISHER saved ground chasing the pace, came out into the stretch, split rivals past midstretch and was outfinished. AGGIE ENGINEER stalked inside then a bit off the rail, bid outside a rival on the backstretch, took a short lead on the second turn, fought back between horses in midstretch, drifted in some in deep stretch and weakened late. PORFIDO (CHI) pulled a bit on the early lead outside a rival, angled in and set the pace inside, dueled along the rail on the backstretch and second turn, fought back in the stretch, was in a bit tight in deep stretch and weakened. MUHANNAK (IRE) allowed to settle a bit off the rail then angled in on the first turn, came out some on the second turn while dropping back and had no response in the stretch.
