SUGAR SHAKE sped to the early lead, set all the pace a bit off the rail, drifted in some in the stretch but held on gamely under urging.
ERMINE stalked outside a rival then three deep into the second turn, continued off the rail leaving that turn, was floated out a bit into the
stretch, drifted out late but held second. RAHYS' APPEAL stalked the winner outside then four wide leaving the backstretch, continued outside
the runner-up on the second turn, came four wide into the stretch and bested the others. FREAKIN STREAKIN pulled her way along and
steadied nearing and again into the first turn, was in a bit tight off heels leaving that turn, stalked inside on the backstretch and second turn and
could not summon the necessary late kick. SEAFREE broke in the air and slowly, settled inside, was in tight off heels into the first turn,
continued toward the rail, came out on the second turn and moved up, went four wide into the stretch and lacked the needed rally. RIVER
SAVAGE (BRZ) reserved chasing the pace outside then three deep, entered the stretch alongside a rival, drifted inward in the drive and did not
rally. DONA AMELIA (CHI) stalked inside then between horses, angled back to the rail on the second turn and weakened. POLITICAL WEB
pulled her way between horses and steadied off heels into the first turn, chased between foes on the backstretch and second turn and gave
way in the stretch.
