ALPHA KITTEN stalked off the rail then outside a rival into and on the turn, came three deep into the stretch, gained the advantage outside foes just past the eighth pole, kicked clear under urging and held. EVITA ARGENTINA settled off the inside then angled in on the turn, came out leaving the turn and into the stretch and finished well to be second best. NAN broke a bit slowly, saved ground off the pace, came out on the turn and into the stretch and just got the show. CANDILEJAS had good early speed and set a pressured pace inside, fought back on the turn and until midstretch and weakened but just lost third. DEEVEETEE prompted the pace three deep then stalked off the rail into the turn, dropped back nearing the stretch and weakened. EMPRESSIVE LADY dueled between horses then outside a rival, was between foes again nearing midstretch, then weakened. TURTLE CREEK BABE had speed between foes then angled in and stalked inside, dropped back leaving the turn and had little left for the stretch.
