CENTURY PARK quickly stepped to the front, dictated the pace while slightly off the rail, responded late on the second turn, drifted out some exiting that bend and safely held under strong handling. HAKA settled off the pace, hugged the rail throughout, found clear path inside ACTING LADY through the drive, loomed inside winner in deep stretch and finished very willingly. WILL O WAY settled while bit off the fence, chased from between foes and two wide to the stretch, rallied in the drive and gamely gained third. LADY LUMBERJACK tracked the pacesetter from outside rival to second turn, moved up bit, loomed outside winner approaching the stretch then three wide into the lane, came out in midstretch, was straightened and lost third. ACTING LADY stalked from the inside, came off the fence leaving the last turn and weakened some in the drive. DAVE'S REVENGE settled off the rail, chased outside then three wide, angled out on final turn, caught five wide into the stretch and failed to threaten. TORO BONITO four wide into first turn, chased three wide, came out bit into the stretch and weakened. CRAZY TRICIA taken in hand early and crossed over, lagged back early inside, later shifted out, chased four wide leaving the last turn and was no factor. JEMMEALEY between foes chasing the pace then three wide, shifted out and caught five wide into the stretch, came in some late and failed to menace.
