SIDNEY'S CANDY sped to the early lead, set the pace a bit off the rail then inside, inched away just off the fence in the stretch, drifted in some and drew clear under a couple cracks of the whip and steady handling. TINY WOODS had speed outside the winner then stalked off the rail, continued alongside a foe into the turn, was no match for the winner in the drive but clearly second best. CLASSICAL SLEW stalked off the rail then three deep, continued outside a rival on the turn, came three wide into the stretch and bested the others. RUNAWAY BANDIDO chased outside or off the rail, went three deep leaving the turn and into the stretch and lacked the needed rally. QUIET INVADER pulled a bit while moving up inside on the backstretch, stalked along the rail, remained on the fence in the drive and weakened. GILLIGAN allowed to settle a bit off the rail then inside, came out into the stretch and was not a threat. RAGING WIT chased off the rail then between horses, fell back some on the turn and weakened.
