A THREAD OF BLUE established control using his own power after losing its footing springing from the starting gate, cut over to the rail before

departing the homestretch, rated kindly carving out the pace, with an equally-rated FLYING SCOTSMAN in attendance out in the two path,

continued along under the same set-up setting split after split, arrived at the quarter pole with some of the closest pursuers being feverishly urged

along, shifted into path two when asked for more himself in the vicinity of the three-sixteenths marker, dug in with good determination to fend off a couple of strong challengers. DIGITAL AGE (IRE) away in good order, was in path two in between rivals travelling on the clubhouse bend, picked

with sufficient clearance with which to launch a rally, did so, rallying with good energy to secure the show. SOCIAL PARANOIA tracked the

winner from the pocket until the end of the second bend, angled three wide into the lane and took off in earnest after A THREAD OF BLUE,

nudged into path four after losing position to the runner up right around the three-eighhs pole, swung into the lane and had no response. FLYING

it up and out-raced MOHAWK for path three at the midway point on the far turn, narrowed in, was given his cue spinning four wide into the lane, finished with good energy down the center of the course but got staved off. CAPE OF GOOD HOPE (IRE) quickly moved to the inside after the field had been sent off and running, stayed put, although at times straddling its right rim, picked up interest approaching the quarter pole, cut the corner

flattened out. HENLEY'S JOY saved ground during the initial stages, was gradually woked into the three path from the top of the bend to the three-eighths pole, got fanned out into path seven from upper to midstretch, straightened away and rallied mildly. ROCKEMPEROR (IRE) unsettled for a portion of the run leading up to the beginning of the first turn, got guided over to the inside, bided time saving ground, eased to the outside at the five-sixteenths pole, lost some ground being driven out into path five during the initial portion of the stretch, made no impact. KADAR checked getting bumped by an incoming EONS at the start, pursued the front runners alternating between the hedge and the two path, was in the former stepping onto the top of the lane, never made his presence felt. MOHAWK (IRE) strung out three wide on the opening bend, was

SCOTSMAN accompanied the winner from path two until the head of the stretch and folded. SEISMIC WAVE raced three wide on each bend, went seven wide into the lane backing away. EONS out sharply at the start, bumped with KADAR, underwent a two wide pursuit, was asked to pick it by the three-eighths pole, failed to do so and gave way. Owners- 3, Leonard C.
