COTTON BLOSSOM raced just off the early pace from outside, ranged up four wide to challenge on the turn, swung to the front entering the stretch, dug in when challenged in upper stretch, battled into deep stretch and turned back DESIRE TO EXCEL under strong left hand encouragement. DESIRE TO EXCEL stumbled badly at the start, moved in a bit along the backstretch, raced in traffic leaving the far turn, swung out for room midway on the turn, circled four wide into the stretch, drew on nearly even terms with the winner in upper stretch, but couldn't stay with that one through the final eighth. CHIEF OFFICER rushed up along the rail, dueled heads apart for the lead to the top of the stretch and weakened from her early efforts. EXPERTISE raced up close along the rail, awaited room while just behind the leaders through the turn and lacked a strong closing bid. AUDACIOUS CHLOE bobbed at the start, pressed early between horses, dropped back on the turn then steadied to avoid the spill while tiring in upper stretch. ANGEL ISLAND dueled heads apart from outside for a half and checked while tiring in upper stretch. BECKY'S FLUTE broke slowly, trailed for a half while saving ground and lacked the needed response when called upon. FRANCES G was outrun early, swung five wide on the turn then fell in upper stretch and was vanned off. Following a stewards inquiry into the spill in upper stretch there was no reason for a disqualification.
